The Institute of Welfare was founded in 1945 as the professional organisation for welfare practitioners undertaking a broad range of social welfare roles within national and local government departments, voluntary welfare agencies and in many instances within the private sector, either as employees or in a voluntary capacity. It has changed and broadened over the years to encompass all those engaged in **people support and guidance** in the broadest sense, whether utilising welfare and/or counselling skills to assist with health, welfare and well being issues in the workplace or a social setting. The Institute gained charitable status in November 2011.

## Corporate Membership

Corporate Membership of the Institute of Welfare is open to organisations who work in the field of people support and guidance in the broadest sense.

Membership is a statement of an organisation's commitment to welfare.

Benefits of Corporate Membership are:

- A *visible* statement of an organisation's commitment to welfare
- A recognised and respected Code of Ethics and a Code of Practice which members must work within
- Reduced membership fees (£60 p.a. 2015) for individuals employed by the corporate member
- An agreed number of sets of the 3 issues p.a. of Welfare World Journal
- The opportunity to contribute to Welfare World (which is currently distributed in 8 countries)
- The addition of any reasonable number (as determined by IoW) of e-mail addresses to the E-mail Information Exchange Group
- An agreed number of training places at CPD/networking events
- Free advertisement of job vacancies on the IoW website and via E-Bulletins to members
- Welfare advice available via e-mail or telephone
- The opportunity to have own internal training courses accredited by the Institute
- The opportunity to buy additional sets of Welfare World and training places as required at member prices

Where corporate membership is taken up no individual is a full member able to use 'letters'. Individuals of the organisation may, of course, be full members in their own right if they meet the required criteria.

## Subscription Fees for Corporate Membership

### Scheme A
